## **VOLUNTEERS APPLICATION & REGISTRATION FORM**

This document must be completed by all persons wishing involvement with the Club, to ensure that the Club works within the guidelines governing Child Protection. This includes all Team Managers, Coaches & Parent Helpers.

A Volunteers Register will be held by the Club to safeguard the welfare & safety of the children within the Club. This form should be completed as comprehensively as possible & all information stated should be correct to the best of your knowledge.

**The Club cannot run effectively without Volunteers!**

**TEAM MANAGERS:** Team Managers must be at a minimum FA Junior Team Manager qualified or FA Level 1 qualified. New Team Managers must commit to taking the FA Level 1 qualification within 12 months.

**COACHES:** Coaches must be at a minimum FA Junior Team Manager qualified or FA Level 1 qualified. New Coaches must commit to taking the FA Level 1 qualification within 12 months.

**PARENT HELPERS (in a coaching capacity):** Parent Helpers may help out at coaching sessions & do not have to become FA Level 1 qualified, but they must take the FA Child Protection certificate. Parent Helpers may also take the FA Emergency Aid course but this is optional.

The Club will pay for all the above relevant football coaching courses providing that the candidates commit to helping out at coaching sessions for the Club for 12 months. Otherwise the full cost of any course may be claimed from the candidate depending on the circumstances that arise. The Club actively encourages coaches to further their coaching qualifications & aim for taking their FA Level 2 & 3 certificates.

Photocopies of all certificates taken must be forwarded to our Club Secretary as they have to be presented periodically to the County FA as part of the FA Charter Standards.

**PARENT HELPERS (in an admin capacity):** Parent Helpers, who wish to help out with the administration of their age group or for the Club, must also complete a Volunteers Form as they will be dealing with personal information appertaining to the players.

**CRB CHECK:** If you hold a current FA CRB check please provide me with your clearance number & clearance date with your application form. All Club Volunteers are required to complete the F.A. CRB check process, as theirs is the only one that the Football Association will accept.

**CLUB MEETINGS:** Our Club holds regular Club Meetings the dates for which are posted on the Clubs internet forum that all volunteers have access to. It is a requirement that Team Managers & coaches attend these meetings whenever possible. It is the Team Managers responsibility to ensure that a coach or a parent from their age group attends on their behalf, if they are unable to make a meeting date.

**COACH DEVELOPMENT:** Our Club holds regular Coach Development sessions. Team Managers, coaches & coaching parent helpers are required to attend these sessions whenever they are able to do so. The idea behind these sessions is for Team Managers & coaches to meet up & swap coaching ideas & techniques. These sessions are particularly useful for those taking coaching courses.
